RELEVANT LEGISLATION:

Provincial (cite)- Municipal Government Act (MGA), section 280(1)

BACKGROUND/PROPOSAL:

In accordance with Section 280(1) of the Municipal Government Act (MGA), Council must appoint auditors for Kneehill County. With the conclusion of the previous 5-year audit term in 2022, a new appointment is required. Administration proposes a one-year extension to facilitate the issuance of a Request for Proposal (RFP) for auditors covering the next 5-year term starting in the 2024 fiscal year. BDO Canada LLP – Red Deer (BDO) has been Kneehill County's auditors for approximately 23 years (fiscals 2000–2022), securing the most recent 5-year term (2018–2022) through a successful RFP process. Administration recommends a one-year extension, followed by a new RFP process for the auditors in the 2024 fiscal year.

Additionally, Council may choose to request or forego an audit planning meeting with the appointed auditors for the 2023 audit. If desired, this meeting will be scheduled for a future meeting date, allowing the appointed auditors to present and discuss the audit plan for the 2023 fiscal year.
