Process and schedule for oral submission

Exhibit 28501-X0456 (attached) was issued on December 4, 2023, and assigns you a timeslot to make an oral submission to a panel of three AUC Commission members. When it is time for you speak, the panel chair will invite you to make your submission. The AUC appreciates your cooperation in adhering to the established time frame to ensure that all stakeholders have an equal opportunity to contribute.

On the day you are scheduled to speak, please use the Zoom link below to join the virtual session at the start of your scheduled time. Please do not share this link with any other party outside of any members of a group you may be participating with.

When you click on the link to join the session you will be placed in a virtual waiting room and will be admitted to the session when the panel is ready to hear your submission. Please note that you may be in the virtual waiting room for a period of time before the panel is ready to hear your submission. While the AUC will adhere to the timelines as best as possible, you may be called on to speak at any point during your assigned timeslot. The virtual waiting room will be continuously monitored by AUC staff. Please ensure that you are participating in the virtual session using the same name that you registered with (the same name identified at the top of this letter). The AUC will not admit participants who are not registered and will deny participation to any name that does not correspond with a registered party.

Procedures

- The panel chair will open and close the virtual session.
- All participants will be asked to identify themselves orally before presenting their oral submission or responding to questions.
- Questioning of experts will take place under oath or affirmation. Oaths or affirmations will be administered virtually by the court reporter.

Recording and transcription

- A court reporter will transcribe the virtual session. For the purposes of obtaining an accurate transcript, please speak slowly and clearly. Participants are requested to refrain from speaking at the same time.
- An audio and/or video broadcast of the virtual session will be archived on the AUC's YouTube channel until the proceeding record is closed.
- For this proceeding, the AUC will purchase access rights to the written transcript and make it available through the AUC's eFiling System.
