Attached Information – Linden & District Agricultural Society Application to Purchase a New Snow Blade

Organization Description

The Linden Agricultural Society is a community organization dedicated to promoting strengthening a rural community through community engagement, and recreational activities in Linden, Alberta. The society maintains various facilities such as the pathway from town to the nursing home, the outdoor rink, and support buildings to foster outdoor recreation and community gatherings. Additionally, they organize and host numerous events throughout the year, fostering a sense of community spirit and cooperation among residents. Through its activities and initiatives, the Linden Agricultural Society plays a vital role in enriching the social and cultural fabric of the community.

Project Description: Purchase of Snow Blade for Linden-Nursing Home Pathway

Overview: The Linden and District Agricultural Society, in collaboration with local farmers, established a vital pathway connecting the Village of Linden and the Linden Nursing Home fourteen years ago. (It is important to note this pathway is located on the private land of Kneehill County farmers, who believed in the project enough to allow this to happen, however maintenance falls to Linden Ag Society volunteers) This pathway serves as a crucial link for the community, including the Linden Lodge, enhancing accessibility and connectivity. However, maintaining the pathway, especially during winter months, has been a challenging task for volunteers. To address this, the Society borrowed a specific type of snow blade for testing purposes, which significantly improved snow-clearing efficiency and safety. Consequently, the Society aims to procure its own snow blade to ensure continued maintenance of the pathway, promoting safety and accessibility for all residents.

Project Objectives:

- Purchase a snow blade to facilitate efficient snow removal along the Linden-Nursing Home pathway.
- Enhance safety and accessibility for residents, particularly during winter months.
- Reduce volunteer effort and time required for pathway maintenance.
- Ensure sustainability and longevity of the pathway as a vital community asset.

Project Scope:

- Procurement of a suitable snow blade tailored to the needs of the Linden-Nursing Home pathway.
- Installation and testing of the snow blade to ensure proper functionality and compatibility.
- Training volunteers on the operation and maintenance of the snow blade.

Conclusion: The acquisition of a snow blade for the Linden-Nursing Home pathway represents a critical investment in the safety and accessibility of our community. By securing this equipment, the Linden and District Agricultural Society aims to continue its commitment to serving the needs of residents and maintaining essential infrastructure for years to come.

The project that we have in mind is putting a defibrillator in the Huxley Community Hall, located at 225 main street in Huxley. We believe there is a need for one in the Huxley community, as many different events take place there throughout the year, between the community hall, curling rink, and ball diamond building. As the community population is aging, and there are sports events being held both at the ball diamond and curling rink, we feel this defibrillator is a necessary life saving tool, as the nearest other defibrillator is located at least 15 minutes away.

The technology today associated with defibrillators makes them very easy for the general public to use, you do not need special training to know how to use one. The local Trochu fire chief has agreed to assist us with maintaining the defibrillator unit, to ensure it is checked frequently and is in good working order.

The Huxley Legion members and the Huxley Community Association members will work together to both order and install the defibrillator in the hall. We anticipate to have roughly 4 legion members, and 4 HCA members working on this project, which will take roughly 3 volunteer hours to complete.



Three Hills Gymnastics New Competitive Suits & Air Mat Detailed Project Description

Mandate:

The mission of the Three Hills Gymnastics Club is to provide a safe, inclusive, and nurturing environment where individuals of all ages and abilities can develop their physical, mental, and emotional well-being through the sport of gymnastics. We aim to foster a love for movement, promote lifelong healthy habits, and empower our members to reach their full potential both inside and outside the gym.

Location: Three Hills Community Centre

Overview: The Three Hills Gymnastics Club is embarking on a project to acquire new competitive suits for its competitive gymnasts and an air mat to enhance training opportunities. With the current competitive suits showing signs of wear after years of use and limited access to a spring floor due to space constraints at the Three Hills Community Centre, these investments are crucial to maintaining the club's competitive edge and providing a safe and effective training environment for its athletes.

Project Components:

New Competitive Suits:

The current competitive suits used by the gymnasts are several years old and have been shared and swapped among athletes for at least five years.

An air mat would provide a safe and versatile alternative for gymnasts to practice their tumbling skills, even on days when the spring floor is unavailable.

The air mat's portability and ease of setup make it an ideal solution for maximizing training opportunities within the club's limited space, ensuring that gymnasts can continue to develop their skills effectively.

Benefits to the Community:

Enhanced Safety and Comfort: The acquisition of new competitive suits will ensure that gymnasts have access to attire that is in optimal condition, providing enhanced safety, comfort, and performance during competitions and training sessions.

Improved Training Opportunities: The addition of an air mat will expand the club's training capabilities by providing gymnasts with a suitable surface for practicing tumbling skills, even in the absence of a spring floor. This will allow athletes to progress and refine their techniques more effectively, ultimately improving their performance in competitions.

Linden Benevolent Society o/a Linden Lodge Window Project Information

The Linden Lodge was built in four different Phases, the first being completed 30 years ago in 1994. The windows in Phase 1 are desperately in need of replacement. They are old and not very energy efficient. They let a considerable amount of heat in, which makes summers in that phase uncomfortable at best. A number of the residents have air conditioning units, which is a significant draw on our electricity. We would like to get these windows replaced to make it much more comfortable for the residents.

The project is a large one, encompassing all 12 suites in Phase 1 along with large dining room windows. We have tried to obtain funding for through the Community Facility Enhancement Program but have been informed that they prioritize non-residential facilities such as rec centers, so we have been unsuccessful.

We are coming to you now to get funding for at least part of the project. We are starting on the most urgent areas, which is the south side of Phase 1, encompassing six suites. We are actively pursuing funding for the rest of the project and hope to have it all completed within 3 years.

We began as a lifelong learning program offering valuable continuing education and general interest classes for adults. In 1995, we incorporated as a provincial nonprofit. We are the Community Adult Learning Program for Kneehill County. In 2022, we became the provincial newcomer settlement and integration provider and provide support for newcomers to Canada and local employers of Temporary Foreign Workers. We had over 1,100 registrations for our programs and services in 2023, benefiting the people of Kneehill County through:

- ESL classes and tutoring
- literacy and numeracy tutoring
- basic digital skills training
- provincial newcomer services and supports
- · community workshops
- support and information for parents with children who have Learning Disabilities
- book clubs and learning opportunities for adults with diverse abilities
- Food Safe training and Babysitting courses

- volunteer mentoring for Lunch With Friends
- · Cree, French, and Spanish classes
- access to technology (wifi, computer use, fax)
- exam invigilation for local post-secondary students taking on-line university courses
- assistance with forms & applications
- referrals to local organizations and resources
- post-secondary info and planning support
- employment services

We also provide a safe place for other valuable organizations to meet with their local clients. These organizations include:

Project Information:

Over the past few years, we have gradually outgrown our main office and classroom spaces as the need for newcomer services and foundational learning opportunities has increased. We have a great strategic and convenient primary location on Main Street in Three Hills and did not want to move from this location. At the beginning of the year (January 2024), we decided to rent the building next door, the former Capital offices, and expand our space through an addition. This expansion significantly increases our available programming area and provides office space for other valuable community non-profits to meet with their clients. We can provide more settlement and integration services to newcomers in Kneehill County. We can also increase the number of foundational learning opportunities and workshops for community members.

We used a federal grant to complete the necessary construction to facilitate accessibility for people with physical barriers. This grant also supplied accessible technology for our foundational digital skills program, which is accessed by many seniors. We did a lot of the deep cleaning and minor upgrades ourselves and with volunteers and changed how we allocated the use for each space/room. Now we need to put the finishing touches on our entire office, making it fully suitable for learning, community access, and other programs, including addressing sensory barriers.

Our goal is to maintain the safe and welcoming environment we have in the original office, focusing on comfort, a calm and quiet atmosphere in which to learn, versatility of the space for community and program use, and confidentiality for staff, volunteers, and clients. To achieve this, our project proposal to the Kneehill County Community Grants program includes the following jobs:

- · Enhancing acoustic properties of the walls in two offices
- · Patching and painting walls in our smaller classroom
- Extending and painting walls in our main classroom
- Adding proper cabinets and a small dishwasher to the kitchen area

All activities of this project will be completed within one year of receipt of funds.

Budget Details:

Material costs were estimated from current costs as per Home Depot and Home Hardware. Material contributions are fair market value of materials being repurposed from elsewhere in the building and leftovers from the accessibility grant construction. We are trying to waste as little as possible. Volunteer hours were estimated with input from licensed builders. The skilled labour hours will be completed by licensed builders and contractors, as well as volunteers with professional experience in the area where they are helping us. Our organization functions with the help of dozens of volunteers. In 2023, we recorded over 1000 volunteer hours. Our last major renovation was in 2015 when we first moved into our current location, 409 Main Street. This work was completed with 1630 volunteer hours.
