BACKGROUND/PROPOSAL:

The AUC is in the process of consultations regarding AUC Rule 007 which governs applications for power plants, substations, transmission lines, industrial system designations, hydro developments and gas utility pipelines.

While the opportunity to participate in oral presentations has passed, there is opportunity to participate in written consultations. The AUC is specifically looking for feedback regarding municipal engagement, visual impact assessment methodology, and glare assessment related to solar facilities.

The County has also received a number of letters from individuals concerned about large scale wind energy conversion systems. Examples of two letters have been attached. These are representative of the received letters - all of which have been included in Council Correspondence.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES/OTHER CONSIDERATIONS:

Administration is seeking Council direction regarding the County's involvement in this process as well as other requests contained within the letters.

In addition to participation in the written engagement, the request letters are asking that Council consider further Land Use Bylaw amendments regarding setbacks and environmentally related conditions for wind energy conversion systems, as well as formal designated opposition to wind projects (unwilling host).
