## **RELEVANT LEGISLATION:**

## BACKGROUND/PROPOSAL:

Ruben Scheele has approached the County in his desire to purchase Railway Avenue which lies on the east side of his property within the Ex-Hamlet of Allingham. By closing the undeveloped avenue, and ultimately purchasing the land, it would allow him to maintain the area and increase the size of his lots.

Ruben Scheele and Erin Scheele are the owners of all the lots on the east side of Allingham (East of Park Avenue which include Lots 1 to 5, Block 1, Plan 3251El, Plan 3251 OT (Centre Street) and Plan 931 0366, Block 1, for a total of 6 titles. Should Council and subsequently the Minister of Transportation approve the closure, it would be required of the applicant to survey, purchase and consolidate Railway Avenue into the adjacent lots. A consolidation of all 6 Titles into one title would also be requested.

Closure of Railway Avenue will not interfere with legal access to any other parcels. The total approximate size of all the lots owned by the applicant is 6.6 acres. The closure of the avenue would add an additional 2.0 +/- acres. An Encroachment Agreement is currently registered on title for a garage, which could be removed should the road closure be approved.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES/OTHER CONSIDERATIONS:

Road Closures are governed by the Municipal Government Act Section 22, which states that a road must be closed by bylaw, must be advertised and must be approved by the Minister of Transportation prior to receiving 2<sup>nd</sup> Reading.

Notices will be sent to adjacent landowners within one mile and referral agencies. Referral agencies notified include internal Kneehill County Departments. This process is similar to a Public Hearing for a Land Use Bylaw Amendment. A person who claims to be deemed affected must be given an opportunity to be heard by Council. First Reading is also the mechanism for moving an application into the process.





## FINANCIAL & STAFFING IMPLICATIONS:

Costs to the applicant will be as follows:

- 1. Application fee as set out by Council (1,0000.00)
- 2. All costs associated with Transfer of Land (Survey, Transfer Documents, Registration etc.)
- 3. Appraisal Fee (Kneehill County will request an appraisal from our Assessment Department. It will be up to the Applicant to use Kneehill County's value or hire an outside appraiser).
- 4. Purchase cost of avenue.

Costs to the County will include referrals, advertisements, and hosting the public hearing. Once Railway Avenue has been closed, consolidated and registered with Land Titles, there will be no ongoing annual operating costs.
