### BACKGROUND/PROPOSAL:

Per Council direction, Administration has prepared a draft resolution regarding renewable energy development's role in providing stability to Alberta's electrical grid.

The attached draft resolution asks the Province to establish a minimum threshold of on-demand power that renewable developments would have to provide. This would help to ensure that Alberta's electricity grid develops and expands in a way that is stable, reliable, and resilient.

The proposed resolution does not seek to dictate a specific threshold for power supply, but contemplates that such a threshold could be relative to the size of development. The background contemplates that there are several ways that this could be accomplished, but the responsibility for doing so would fall to the developer.

### DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES/OTHER CONSIDERATIONS:

Administration is seeking further Council input on the draft resolution so that it can be formally submitted to the Central RMA Zone for consideration.

The benefit of Council accepting the recommended motion is that it will provide the Council with a valuable opportunity to advocate on behalf of the County and its ratepayers. The Resolution will be a key tool for the RMA to communicate member concerns to the Province.

There are no perceived disadvantages to the recommended motion.
