BACKGROUND/PROPOSAL:

Kneehill County policies are presented for review every four years (at a minimum). This review by Council ensures the policies will remain current and allows for any modifications to be made based on changing legislative requirements.

This review is regarding Policy 13-1 Commercial Dust Control which allows commercial industry to apply dust suppressant for their needs or when they have entered into agreements with resident landowners to supply a dust suppressant.

Kneehill County Policy 13-4 County Supplied Dust Suppression Calcium Chloride & Spec Crude Product is to improve the quality of life in Kneehill County, dust abatement agents may be applied on rural roads in front of residences and Industrial, Commercial or Agricultural operations.


DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES/OTHER CONSIDERATIONS:

Administration recommends the repeal of Policy 13-1, Commercial Dust Control, as it overlaps with Policy 13-4, Dust Suppression. The revisions to Policy 13-4 now include provisions for Commercial & Industry Supplied Dust Suppression, which addresses situations where commercial and industrial entities are responsible for providing dust suppression for their operations. Aside from minor wording adjustments, there are very few changes to the overall content of Policy 13-4. This consolidation simplifies the County's approach to dust suppression.
