## **RELEVANT LEGISLATION:**

#### BACKGROUND/PROPOSAL:

Early on in the year, we received a call from the Kneehill Area Recreational Hockey Association requesting to apply for a Community Grant.

The Kneehill Area Recreational Hockey Association is a hockey league for Kneehill County and area and they play out of the Torrington Arena.

They are looking for \$800 in grant funding from the County, to install a cell phone signal booster inside the Torrington Arena.

In their letter they have given a couple of scenarios where there were some safety issues happening inside the arena and there was no cell phone service inside the building. There is phone coverage outside the building.

They have done some fundraising and they are able to match the \$800 grant with their own \$800. They have also stated that they have a volunteer parent who is an electrician who is willing to donate their time to install the boosters.

The organization is not eligible for a Kneehill Community Grant as the project cannot enhance or create a fully owned municipal asset. The fully owned municipal asset is Kneehill County's Asset.

#### DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES/OTHER CONSIDERATIONS:

Funding for this project could come from the Community Enrichment Support Program, as this is the grant program that is not covered by other grants.

This application was also reviewed by facilities, and they are in support of this application, but want to ensure that the electrician, before doing any work, is qualified and follows Kneehill County's workplace safety practices.

The Torrington Agricultural Society, who leases the facility from Kneehill County is also aware of this request and have also submitted a letter of support for the project.





#### FINANCIAL & STAFFING IMPLICATIONS:

Kneehill County budgeted \$6,000 for the Community Enrichment Support Program in the 2025 approved budget. Currently, \$4,450 has been utilized, leaving a remaining balance of \$1,550.
