BACKGROUND/PROPOSAL:

Central Alberta Economic Partnership (CAEP) is a regional economic development organization who supports its membership through investment attraction preparedness and capacity-building to grow sustainable, diversified economies throughout Central Alberta. Kneehill County has been a CAEP member for over 15 years.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES/OTHER CONSIDERATIONS:

At today's Council meeting, Paul Salvatore, Executive Director with CAEP presented an overview and update of CAEP's future direction and how CAEP will continue to provide support to its membership.

Currently, Deputy Reeve McGhee is appointed to the CAEP board of directors and Amy Merrill is appointed as a committee member at large. CAEP will appoint its board members at the annual fall meeting in November 2025.

Kneehill County's membership is due for renewal, and thus, a decision is required to determine whether Council wishes to renew for the upcoming year. The membership renewal fee is \$4,017.60 plus GST. The membership fee is calculated at a rate of \$0.80 per capita (5,002 population). When a municipality becomes a member, a representative is appointed to the Board and thus that member would be reimbursed for costs associated for travel and per diem's as per Kneehill County Policy 3-3 – Council Appointees Reimbursement.

FINANCIAL & STAFFING IMPLICATIONS:

Financial contribution for membership renewal is \$4,017.60 plus GST.

Per Diem and travel expenses incurred for the Council-appointed board representative to attend meetings.

CAEP membership and per diem and travel expenses are included in the annual Operating Budget.
